An FDA regulation requires tobacco companies to disclose a list of all additives used in the manufacturing of cigarettes, and cigarettes alone, to the Department of Health and Human Services ( US Code: Title 15, Chapter 36, 1965, Cigarette Labeling and Advertising Act ). Thus, tobacco companies do not have to disclose additives in pipe tobacco, chew or other any other form. So, B and W continued to use Coumarin in pipe tobacco. Their rationale was simple but disturbing. They reasoned that since the law did not require the disclosure of ingredients in non-cigarette products, then they could use any ingredient in these products, including known carcinogens, with impunity. We had many disagreements including the use of the company's mantra hook em young, hook em for life, and the impropriety of lawyer interference in science, among many others. When I urged Mr. Sandefur that Coumarin should be removed from all of B and Ws products, he instructed me to go back to the lab and find a substitute for Coumarin.
